# Title: AS9100 and NADCAP Certification for Aerospace MSMEs

## Abstract of the Talk:

With the advent of the “Open door” and “Make in India” policies of the Govt. of India, MSMEs are increasingly being engaged and attracted into providing products and services for the Aerospace and Defence Industry. MSMEs, in particular, serve the major Indian Defence and aerospace organizations such as HAL, BEL, BDL, DRDO, etc., and also the global primes such as Boeing, Airbus, Raytheon, Honeywell, GE-Aviation, Rolls Royce, etc.

One of the main regulatory requirements mandatory for the MSMEs seeking to work in the AS&D industry is certification to Aerospace Standard 9100, the current version of which is AS9100: 2016. In addition, organizations involved in special processes such as heat treatment, chemical processing, coatings, NDT, laboratory testing, electronics, welding, forging & casting, etc., need to obtain accreditation to NADCAP.

This presentation outlines the emerging challenges and issues faced by the AS&D industry, how AS9100 standard addresses those issues, the salient features of AS 9100 certification, the main focus areas and the incentives given by the State Govt. to MSMEs that go in for this certification.

The presentation also highlights the salient features of the NADCAP accreditation process for Special processors and the competitive and technological benefits of obtaining NADCAP accreditation.
